AGREEMENT REGARDING RESPONSIBILITY

Parade Participant will abide by all rules and policies established for the parade, particularly those requiring adult “walkers”.

I, the undersigned authorized group representative, on behalf of the Parade Participant named on this application (“participant”), hereby agree that participant, and all persons directly or indirectly associated with its participation in the 2011 Kiwanis Club of West Monroe Christmas Parade, sponsored by Ouachita Independent Bank (OIB), agree that we and all of our individual participants will abide by all rules and/or policies established by the Kiwanis Club of West Monroe, Louisiana, Inc. (“Kiwanis”) as a requirement for participation, particularly including the policy that there must be no less than three adults on foot to each side of each trailer or float (or two adults on foot using an appropriate crowd restraint) in order to prevent parade onlookers and others along the parade route from approaching the trailer or float within an unsafe distance and to provide for the general safety of the onlookers and others along the parade route who may suffer injury due to or relating to the trailer or float, or its tow vehicle (if applicable), or other vehicle participating in the parade or other parade activity, as well as to provide for the supervision and safety of those on board the trailer or float.

I further agree, on behalf of the participant, that there will be adequate adult supervision of all minor children, and that all participants have been made aware of the importance of parade safety for themselves, other participants, and spectators during the parade.

Release and hold harmless.

Further, as a condition of participation and for other good and valuable cause and consideration, as authorized group representative for the participant and on behalf of the participant, its officers, employees, agents, representatives, successors and assigns, and including all individuals riding on, in or otherwise participating in the parade with participant, I do hereby expressly waive, relinquish, and release Kiwanis and OIB, their members, agents and designees from any and all claims, actions, rights or causes of action, damages, costs, loss of services, expenses, compensation and attorney’s fees that have or may arise from known or unknown personal injury or property damages arising directly or indirectly as a result of participation in the parade, excluding only the grossly negligent or intentional acts of authorized members of the Kiwanis Club of West Monroe, or their agents and designees.
